## Levengood Ditch Viewing

At 10:30 a.m. Mr. D. Curtis Lee, Mr. Dane R. Shryock, Mr. Gary L. Fischer, Mrs. Mary Beck and Mr. Steve Levengood attended the viewing of a ditch located along side TR 508 next to Mr. Levengood's property. Mr. Levengood stated that State of Ohio cleaned the portion of the ditch just off SR 36. He asked if the Commissioners knew if the right-of-way for the township road is 30 or 60 feet. The Commissioners did not know what the road right-of-way was. Mr. Levengood stated that there is a 9 foot fall from the MacElhaney's driveway to SR36. Mr. Lee stated that on township roads, it is the responsibility of the trustees to maintain ditches. Mr. Levengood feels if it were ditched every year or two, then it wouldn't be that big a deal to maintain. Mr. Shryock stated that the Commissioners are considering the possibility of selling the property to alleviate these issues. The Commissioners intend to discuss the issue with the Prosecuting Attorney and should have some idea after the first of the year what they will do. Mr. Levengood asked that the Commissioners keep him up to date on their decision.
