Discussion - Fresno/Pearl Sanitary Sewer

Mr. Brain Winkler attended the meeting to discuss Pay Request #13. Mr. Lee stated that we have been contacted by William Albert and they have not received payment for Pay Request 12 yet. Mr. Winkler stated that there were several issues with that request. He said that OPWC did request additional information and he sent that to them yesterday. He stated that OWDA needed additional signatures and he got those to them yesterday as well. He is still waiting to talk to John Cleek about the CDBG monies. He also has requested a lien waiver/affidavit for the William Albert invoices last week. He still has not received those to date. Mrs. Schonauer asked when Mr. Cleek was contacted about the CDBG monies. Mr. Winkler stated that he first contacted him a month ago, then a couple weeks ago and today. After talking to OWDA today, they should have the payment processed this week. They will pay William Albert directly and send the remaining to us. Mrs. Schonauer stated that the first Mr. Cleek had heard from Mr. Winkler was last week. Mr. Winkler stated that he did send him an e-mail over a month ago. Mrs. Schonauer stated that when these pay requests are signed in our office on November 8th, why are they not being submitted until almost a month later. Mr. Winkler stated that he sent the information in and they are usually sent in within a day or so. Mrs. Schonauer stated that OPWC told her they did not receive the request until December 3rd. Mr. Shryock stated that if it was not sent in until December 3rd, why is that. Mr. Winkler stated that he submitted these forms on November 18th. Mr. Shryock then asked about the CDBG monies and why they were not requested. Mr. Winkler stated he has sent the information Mr. Cleek will need to make the drawl. Mrs. Schonauer stated that he has requested \$568,000 for CDBG and there is only \$500,000 available for him to drawl. Mr. Winkler stated that we can go ahead and invoice the monies and just move them around. As long as we show that we have billed a certain amount from the line items it will be fine. Mrs. Schonauer reviewed his pay request #12 and he stated that those numbers are in error. She asked if the Commissioners approved part of this request in Pay request #12. Mr. Winkler stated that William Albert has two invoices. One for Fresno and one for Pearl, out of those invoices some are for CDBG and some for OPWC and some for EPA/ARRA. Mrs. Schonauer stated that the CDBG monies should have been requested back in November when he received those invoices. Mr. Winkler stated that he is still waiting on the payment of liens before he can get the monies for the CDBG. Mr. Shryock asked how do we get our local contractor paid on time. Mr. Winkler stated that this paperwork will be sent in to OWDA today to get payment. As for the CDBG monies, it will be requested from John Cleek today. Mr. Shryock asked when we can get the monies from CDBG. Mrs. Schonauer stated that she feels the earliest they will get their CDBG monies will be the end of January.
