## Omnicity Update

Mr. Bob Meissner, Omnicity and Mr. Jon Mosier attended the meeting to give an update on the Broadband Project. Mr. Meissner stated that they have 50 scheduled installs with 38 of those being successful. He stated that the month of December was not as productive as they had hoped. On January 6<sup>th</sup> they installed the client access on the Bakersville tower. The Fresno tower equipment came in shortly after the first of the year and the installation was started yesterday with a completion of that today. They hope to start installs in that area next week. On January 4<sup>th</sup> they upgraded the county link coming from the hospital. Speeds have increased to right around 15 or 16 megs. They are still investigating the problems with this. They hope to have an answer soon. He then stated that Mr. Mosier and Jason Miller looked at a tower that might serve residents in the CR 202 – Airport Road area that will also serve the Three Rivers Fire District. They are doing some studies on possible tower sites that would accommodate this area. Mr. Meissner then stated that things are still moving forward with the possible takeover of the One Community Contract with the county. Mr. Fischer stated that he has been told that some residents who were told by LightSpeed that they could not get service that Omnicity has contacted them and they are able to get service. That being all, the Commissioners thanked him for his update.
