# 2<sup>nd</sup> Public Hearing – 2011 Formula

At 9:00 a.m. the 2<sup>nd</sup> Public Hearing for the 2011 Formula Projects were held. Mrs. Beck stated that the county will receive \$110,000.00 in Formula funding for grant year 2011. The following projects will be included in the grant application that will be presented to the Ohio Department of Development: \$10,400 – Village of West Lafayette, Street Improvements, Street Signs, \$64,000 – Village of Warsaw, Street Improvements, Resurfacing various village streets, \$13,600 – Neighborhood Facilities, First Step Family Violence Intervention Services, Electrical Upgrades and \$22,000 – Administration/Fair Housing. There were no other persons in attendance. At 9:15 a.m. Mr. Fischer closed the public hearing.

Litter Truck – Mr. Jeff Wherley

Mr. Jeff Wherley attended the meeting to discuss the recent vehicle issues that the Litter Department has been having. He stated that they have had some brake issues on the back-up truck and the truck they are now using will now cost them over \$8,000 to repair. He stated that he feels they need to request the new vehicle at the next board meeting. He asked the Commissioners what they want to do with the old truck as he feels it will cost more to repair than the truck is worth. The Commissioners told him to contact the district to start the process of seeing if anyone in the district is interested in the truck. They also asked him to take the State Purchase price of the new truck and see if any local dealership can match that price.

### WODA Olde Hickory Discussion

Mr. Ike Reger, Mrs. Tiffany Swigert, Mr. Don Brown and Mr. Don Wells attended the meeting to discuss the mowing of the county owned parcels in the WODA Olde Hickory Subdivision. Mr. Fischer stated that we are wondering where we left the mowing issue with the Tuscarawas Township Trustees. Mr. Shryock stated that originally we were going to charge an assessment on the resident's water/sewer bills of \$5.61 per month. We did get a Prosecutor's Opinion and it stated that we could not assess their water/sewer bills, it would have to be assessed on the Real Estate Taxes. Mr. Reger stated that there really has been no mowing done in the subdivision outside the actual home lawns. Mrs. Swigert stated that the WODA Manager contacted the County Engineer's Office to see why we have not done any mowing. Mr. Lee stated that we are only responsible to mow what the county owns and that is parcels A and B. Mr. Shryock asked what the Township's opinion on this issue is. If we ask them to mow, we won't have any funds collected until next year. Mr. Brown stated that they had intended to utilize the pine trees to stop weed growth around the retention pond, they would like to wait and see how the trees do with all this rain to determine if they will be able to be saved. He asked if they were to do the mowing, would there be a problem with them being on the county property. Mrs. Swigert stated that if they have an agreement with the Commissioners there should be no problem. Mr. Fischer stated that he feels we need to contact WODA to determine why they are not mowing the areas that are theirs to mow. Mrs. Swigert stated that she will call WODA to find out why they are not mowing and what they expect the county to mow. The Commissioners stated that our maintenance department will do the mowing of parcels A, outside the fence and B this year if WODA does not agree to do it and then possibly contract with Tuscarawas Township next year. Mr. Fischer thanked everyone for attending.
