Senior Center – Senior Levy

Mr. Mike Stephens, Ms. Donna Denning, Ms. Jamie Thomas attended the meeting to discuss the Senior Center Agreement. Mr. Stephens stated that we have approximately \$64,000 set aside for maintenance of the Senior Center. Ms. Thomas stated that fortunately they don't have a lot of maintenance issues, but when they do, they call the County Maintenance Department and the county will make the necessary repairs. They do purchase the materials and the county does the labor. She would estimate that they call the county once every other month or so. They have been very good in working with them. Mr. Shryock asked if they do the snow removal and Ms. Thomas stated that they do plow the parking lots. They are very good about making certain the parking lot is clean. Mr. Shryock then asked if they have any thoughts about repair or replacement of the parking lot. Ms. Thomas stated that to date there have not been really any issues with that and looks to be in good condition. Mr. Lee asked how much they set aside each year for expenditures. Mr. Stephens stated that they did not put any funding in that line item this year since they already have \$64,000 in the fund. Mr. Shryock stated that just for clarification, they will take care of all maintenance costs outside of the labor the county can provide. However, if the maintenance department is unable to do the labor for the repair, they will be responsible for pay all costs of the

repair. Mr. Stephens stated that he will put stated that he will put this language in the lease. Mr. Stephens will put this language together and send it back over to the Commissioners within the next two weeks for their review. That being all, the Commissioners thanked them for attending.

Sansdecker, CPS

Mr. Scott Sands and Mr. Angelo Kallipolitis attended the meeting to introduce their company Sandsdecker. Mr. Sands stated that they are a small company based in Columbus and have offices in Zanesville and Logan. They started this firm 13 years ago and do engineering, surveying and land planning. They are here to let the Commissioners know that they would like to do work for the county and if they have any projects they hope the Commissioners give them an opportunity to do the work. He stated that they have done a lot of school projects as well as water and sewer projects. Mr. Lee stated that right now there really isn't much on the horizon for the county. Mr. Shryock stated that at this time we are just finishing up with a small water project but have nothing in the near future planned. He asked if they will respond to an RFP request and Mr. Sans stated that this is why they have come in today, just to make certain we know who they are. The Commissioners thanked them for attending.

EMA Employee Discussion

Mr. Jim VanHorn attended the meeting to discuss the position that will become available when Jordan Seib leaves July 29th. He stated that they have advertised for this position and have received a few resumes. At this time, he will continue down this road and go through the resumes and interview process. He feels this is not an emergency situation as he and the EMA secretary can handle the office while this process goes forward. One thing he would like to consider is to make this position a full-time position from the beginning and not starting out as part-time. He would also like to give the secretary a 3% raise with the additional work she will be required to do once Jordan is gone. He may also have to increase his hours back to 40 per week until the position is filled. That being all, the Commissioners thanked him for the information and update.
