Blue Star Mothers – Kiosk Request

Ms. Nelva Fogle and Ms. Bess VanAtta attended the meeting to discuss the possibility of putting a Kiosk to display pictures of active military. Ms. Fogle stated they are attending to ask permission to place the structure on the Court Square. At this time, they have them in the store windows on Main Street. They would like to put them all in one place. Mr. Lee asked what type of glass they would use. Ms. Fogle stated that it is made of recycled material and the glass would be plexy glass. The structure is approximately 5 feet long and 2-3 feet wide. Mr. Lee asked about lighting. Ms. Fogle stated that they would like to have lighting, but they would need access to electricity. Ms. VanAtta stated that they could also use solar lighting. Mr. Shryock asked about maintenance and up-keep. Ms. Fogle stated that the Blue Star Mothers would be responsible for maintenance and up-keep. She stated that they intend to do fund-raising for this project which they anticipate to cost around \$6,000.00. She said that they have also applied for a grant that will match whatever they can raise. Mr. Shryock stated that as to the location of the kiosk, we do need to run this past the Common Pleas Judge but they thought possibly it could be placed on the corner of 4th and Main Streets across the sidewalk from the Rotary Community Sign. He then stated that he feels their ability to place the kiosk on the court square will be based upon raising the funds and being able to provide for the maintenance and up-keep of the kiosk. Ms. Fogle stated that they are required to have a location in order to apply for the grant funding. Mr. Shryock stated that they will make the appropriate contacts and get back with them on the availability of that spot on the Court Square.
