At 9:00 a.m. Mr. Shryock opened the public hearing. Ms. Marilyn Bucklew, Ms. Sue Johnston and Mr. Brian Simmons attended the public hearing. Mr. Shryock asked for public comment. Ms. Bucklew asked if we know what is in the brine because this could run-off onto public property. Mr. Shryock stated that they call it salt brine, but that is not a requirement of this office. He stated that this office is required to complete the application having a public hearing. The state is the regulatory entity. Ms. Bucklew stated that she feels we should know what is in the brine if we are permitting the application. Mr. Shryock stated that statutorily, they are required to file the application once we receive it and verify that they have followed the required procedures. Ms. Bucklew feels this is a catch 22. We approve something and assume everyone will do their job. Mr. Fischer stated that if we have to check to make sure everyone before us does their job we would never get anything done. We rely on the agencies to do their job so we can do ours. Ms. Johnston asked if they can change the formula of the brine. She is concerned that they will use fracking chemicals. Mr. Shryock stated that these wells are existing wells and are listed with ODNR. This brine water they are using now is already there and naturally occurring. At 9:15 Mr. Shryock closed the public hearing. Mr. Lee made a motion, seconded by Mr. Fischer to sign Resolution 2012-16 for the surface application of salt brine by NGO Development, Newark, Ohio.

Humane Society – Dog Numbers at Shelter

Ms. Marilyn Bucklew, Ms. Sue Johnston, Mr. Rusty Dreher, Asst. Dog Warden, Mr. Steve Cox, Dog Warden, Ms. Anne Bucklew and Mr. Ralph Harrell attended the meeting to discuss the dog numbers at the shelter. Mr. Shryock welcomed everyone and gave the floor over to Ms. Bucklew. Ms. Bucklew presented the Commissioners with a spreadsheet. She stated that she is not here to get anyone in trouble she is just trying to figure this out. She then explained her spreadsheet to the Commissioners and showed that there is some type of accounting problem here. She stated there is a discrepancy from Steve's reports to what the shelter reports are. She feels that these discrepancies need to be addressed because if our numbers don't match then the Humane Society is required to pay. Mr. Cox stated that if the Humane Society would keep a pound keepers book it would solve all problems. Mr. Cox stated that our numbers and the shelter numbers will never match because the Dog Warden will pick up dogs and not always take them to the shelter. We do not expect the shelter to account for these dogs. Mr. Shryock stated if every dog that comes into the facility is documented no exceptions; there should not be an issue of unaccounted for dogs. There should never be a dog not reported in the pound keeper's book. Ms. Bucklew stated that the design of the building is not conducive to having only one employee there. Mr. Shryock stated that it should still be accounted for somehow. If they find a dog in the parking lot, then it should be accounted for.
