### Shale Direction and Programs – Mr. Joe Barone

Mr. Joe Barone attended the meeting and presented the Commissioners with information about Shale Directions and Programs. Mr. Barone stated that he started a business that helps the oil industry communicate with local industry. Their goal is to make it easy for everyone to get information. He stated that Belmont County, Harrison County and the City of Canton have signed on as well. He feels it is very important for people to be able to access information about local officials and news that is going on in their county. He stated that by making this information available to the gas companies it helps economic development and growth. The cost is \$2,500 per year to participate in this program. They would like to work with the County, Chamber and the Port Authority to get this information. Mr. Shryock stated that the Commissioners will take his proposal under advisement and get back with him. They thanked him for attending.

#### Frontier Power – Mr. Tom Barcroft

Mr. Tom Barcroft attended the meeting to request the build of a tie line to help with the issues they are having in the Chili area. He would be running this new line across the county owned property in the area of the Hydrologic Station. He presented them with a map showing where the new line would be. Approximately 900 feet of the line would need to have the trees removed. He presented them with an easement that Frontier Power uses. Mr. Shryock asked if the line would be along the road. Mr. Barcroft stated that he will build the line as close to the road as possible. Mr. Shryock stated that we have a lot going on in that area right now. We have a timber bid out at this time and we need to determine if that would affect any of this. Mr. Barcroft stated that he intends to go up the west side of the road until he gets to almost the end of the county property and then cross over to connect to the existing line. Mr. Lee stated that he feels this will not affect us to much with where they intend to go. He doesn't feel there will be interference with our timber harvest. Mr. Barcroft asked for a verbal ok from the Commissioners today. Mr. Shryock asked Mrs. Beck to contact Mr. Joel Berry, our forrester to make sure this will not interfere. Mr. Shryock stated that the Commissioners have no issue giving a verbal ok at this time and they will forward the easement on to the Prosecutor for his review. The Commissioners thanked him for attending.
