## Government Innovation Fund Application

Mr. Fred Wachtel attended the meeting to discuss the Government Innovation Fund Application. Mr. Wachtel stated that we have Ohio University (OU) working on updating our GIS. He stated that OU is working in conjunction with Gallia County to apply for funding through the Government Innovation Fund to come up with a program that would get this information out on the internet and keep it updated. He stated that they are requesting a resolution from each county to be part of the study for this collaborative effort. Mr. Shryock asked if he sees this as a benefit for the equipment and software utilization, but not the employees. Mr. Wachtel stated that the software and maintenance would be utilized there, but we would still have to update and input the data. This would just take the data and take it to the next level. Mr. Shryock asked if this is something we need to do. Mr. Wachtel stated that at this point it can't hurt to be involved, but once they determine if they can do this, then we have to decide if the economics will benefit us to continue to do what we are doing or to go with them if there is a cost savings. Mr. Shryock stated that he would not have a problem with looking into the possibility then and wait and see what happens. Mr. Wachtel stated that he would suggest they complete the resolution of support, letter of support and memorandum of understanding and see where things go from here. He stated that they need to have everything completed by the end of this month. The Commissioners asked that it be put on the agenda for Monday. The Commissioners thanked him for attending.
