County Road Maintenance Agreements

Mr. Fred Wachtel, County Engineer, Mrs. Dorothy Skowrunski, Coshocton Port Authority and Mr. Brian Simmons, County Utilities Director attended the meeting to discuss the Townships as well as the County's Road Maintenance Agreements. Mr. Wachtel stated that approximately a month ago he had a meeting with the Township Trustees and it was decided then that they should come up with a program that will address issues pertaining to the Road Maintenance Agreements in Coshocton County. He stated that they felt it should be a program that should start with one person and they could steer them in the direction they feel they should go. Then if the Township or the County felt they needed assistance with anything they could ask for help. He then stated they thought it might be best if the initial starting point was at the Commissioners Office. He presented the Commissioners with a suggested plan. Mr. Lee stated that he liked the idea of the first contact coming to one spot and then being directed out. He stated that he is not certain how much he would like to be involved after that though. He understands that some townships will not want any involvement and others will want to take it all on. Mr. Wachtel stated that after the initial application then the point person could sit down with the township and let them know what is going on and what has happened in the past. Possibly just to give advice or see how much assistance they will require. Mr. Wachtel stated that he would like to know where the point person will be. Will it be in the Commissioners Office or the Engineers Office? Mr. Shryock stated that as long a Mr. Simmons is employed by the Commissioners he is alright with him being the point person for this county. If he would happen to leave this office, he would not know if we could replace him with someone with the experience he has to be able to go out and work with the oil companies. Mr. Lee stated that he does feel we need to request that every township utilize the same Road Maintenance Agreement. He feels this will help greatly in dealing with the oil company as well as the Prosecutor and the Townships. If the Township does not want to utilize the Standard Road Maintenance Agreement then we will not be that Townships point person. Mr. Lee stated that he feels this will not only benefit the townships and county but the oil companies as well. Mr. Wachtel stated that he will present this proposal to the Township Trustees on Friday night. The Commissioners thanked him for attending.
