Discussion – Leasing of Cruisers

Lt. Bill Kobel, Lt. Jim Crawford and Lt. Dean Hettinger attended the meeting to discuss the leasing of Sheriff Vehicles. Also in attendance was Robin Schonauer, Budget Director. Mr. Shryock stated that he previously spoke with the Sheriff about a process the Sheriff had heard of from Muskingum County about the possibility of leasing Sheriff Cruisers. We did do some research on this and got information from the leasing company. Mrs. Schonauer stated that she contacted the state term pricing and as long as we piggy-back the lease on the state term contract; we can lease the vehicle or vehicles. She stated that for a three year period, we could lease three

vehicles at \$25,000 per year. She also stated that there is a state term contract with Ford as well as Dodge for cruisers, so we could do which-ever one the Sheriff would like. Lt. Crawford asked if there were mileage restrictions. Mrs. Schonauer stated that there is no mileage restriction. Mr. Shryock stated that just in talking, on the county side, how many vehicles does the Sheriff think they will need and on what type of time frame are they looking at. He really doesn't like to go past 5 years old on a vehicle. At this time he has a total of seven county vehicles for all three shifts. Mr. Shryock asked how he would rotate these vehicles out. Lt. Crawford stated that he would probably rotate the old vehicles to do transports. Mr. Shryock stated that we are looking at options and wondering what the Sheriff thinks about the direction we are thinking about going to. Mr. Shryock stated that it just seems like this would be an easier option to budget for. Lt. Crawford agreed. The Commissioners thanked them for attend.
