Airport Board - Request for Funding

Mr. Craig Casey, Mr. Tim Cox and Mrs. Robin Schonauer attended the meeting to request funding for the Coshocton County Airport. Mr. Cox stated that the Airport has a bill outstanding to William Albert for 70,981.94. They would like to get him paid. The funding they are waiting on is FAA addendum monies and with the budget constraints at the FAA as well as employment changes there, the Airport is waiting on the funds. They are asking if the Commissioners could pay the full amount, they are assured that the monies will come from the FAA to reimburse the Commissioners. Another option is to sell some real estate to the National Guard. They have a loan with Chase bank that needs to be met with these funds and then they would need to borrow approximately \$22,000 from the Commissioners until the FAA funds come in. Mr. Lee asked if they know when the National Guard check will be issued. Mr. Casey stated that the National Guard has had some issue making their end come together and we are trying to get these funds as soon as possible. Mr. Cox stated that the board is very appreciative of William Albert as they have been very understanding of these money issues. Mr. Shryock then asked if we loan them \$22,000 is there any thought process of how that will come back to the Commissioners? Mr. Casey stated that when the funds come from the FAA they will then reimburse the Commissioners. If the monies do not come by the end of the year, the Commissioners can take the monies from the Airports appropriations for next year. Mr. Shryock stated that if we loan them the full amount now will they then give us a portion of the monies when they get their check from the National Guard. Mr. Lee asked what guarantee do we have that they will pay us when they get their funds from the National Guard. Mr. Casey stated that they have been authorized by the Airport Board to come here and request this of the Commissioners.

Mr. Lee made a motion, seconded by Mr. Fischer to loan \$70,981.94 to the Coshocton County Regional Airport Authority to pay William Albert, Inc. money owed by them and that these loaned funds will be reimbursed by Regional Airport Authority via their funds that they receive from the sale of the National Guard property as well as the FAA funds. If these funds are not reimbursed prior to December 31, 2012 then the Board of Commissioners will take the remaining funds owed from the Airport Boards annual appropriations for 2013.
