#### Electric Savings

Ms. Kathy Tegland, Palmer Energy Company and representing CCAO and Mrs. Robin Schonauer, Budget Director attended the meeting to discuss Electric Savings. Ms. Tegland stated that she represents CCAO in the area of gas and electric savings. She stated that areas that are not REA, are eligible to join together to maximize savings and Coshocton County has some of these areas. She stated they will need to join the CCAO program to opt-out of government Aggregation and then submit to the Board of Elections to be on the ballot. Once they are on the ballot, it would need to be voted on at the township levels as well. Mr. Lee stated that he understood that the City could do this on their own. Ms. Tegland stated that they can only do this on their own city facilities.

Mr. Lee stated that at this time residents have the ability to go on a savings plan with their own company they choose. Ms. Tegland stated that this is true but if this passes on the ballot, these individuals will get the opportunity to opt-out. Mr. Lee asked how they will be able to determine who has REA and who has AEP or other. Most of the county townships are split having both companies. Ms. Tegland stated that it would be up to the trustees or CCAO to come in to make certain they are informed. Mr. Lee asked how long will these residents be locked into the rate. Ms. Tegland stated that everyone gets the information but if the resident has an individual contract, they would not be able to join until that resident's contract is up. The Commissioners stated that we need to have further discussion on this issue with CCAO as well as the townships. They also would possibly like to put our county buildings on the program and see if we have any savings and then possibly put it out to the public if we do see the savings they are saying we will. The Commissioners thanked her for attending.

#### Investment Portfolio

Ms. Breanne Mathews, Deputy Treasurer attended the meeting to present the Investment Portfolio to the Commissioners. She stated that we have collected 77% of the anticipated revenue for 2012 to date. She stated that they are in the process of collecting real estate taxes and feels they will collect as much as they did last year. The Commissioners thanked her for attending.
