Public Hearing – 2013 Estimated Budget/Resolution 2012-44

Mrs. Robin Schonauer, Budget Director, Ms. Christine Sycks, County Auditor and Mrs. Jinni Bowman, Chief Deputy Auditor attended the meeting. Mrs. Schonauer stated the 2013 Estimated budget is complete. Our anticipated revenue is \$8,145,477. This is an increase over 2012. The anticipated revenue to appropriate is \$10,861,411. That is also up from 2012. The expenses are up as well. The departments have requested \$9,730,451. This is also up from 2012. Mr. Shryock asked what the Sales Tax Estimate for this year was and what the casino revenue will be. Ms. Sycks stated that the sales tax is 4.2 million and she has anticipated receiving \$120,000 in casino monies. At 9:10 a.m. Mr. Shryock closed the public hearing. Mr. Fischer made a motion, seconded by Mr. Lee to sign Resolution 2012-44 to submit the Annual Budget for Fiscal Year commencing January 1, 2013 for consideration to the Coshocton County Budget Commission.
