2013 Sheriff's Budget

Lt. Jim Crawford and Mrs. Robin Schonauer attended the meeting to discuss the Sheriff's 2013 budget request. Mr. Shryock stated that we are in the process of working through the 2013 budget at this time. In 2012 their budget was \$2,531,567 and in June 2012 he submitted an estimated budget of \$2,640,074. With this request he was basing it on the old insurance rates. With that being said, there would be a savings of \$88,000. Also, we have to reduce the amount of monies he will be able to utilize from the 911 funds by \$55,000. The Commissioners intend to give the Sheriff's Office these monies from the general fund. At this time, they are looking at giving the Sheriff's Office \$2,695,174. This would be \$55,000 more than he requested in 2012. The Commissioners would like them to add one deputy to be added back to the county. He also asked if they would have a vehicle for this new employee. Mr. Crawford stated that he would have no issue with this as they plan to lease three new cars or they could purchase one new vehicle. He then stated that he feels he can add the new employee, but there may be one hiccup in that they are in fact finding with the union on the deputies bargaining unit agreement. Mr. Lee stated that we can give them the funding but you need to know that things may not be as good in coming years. Mr. Fischer stated that if the funds are not needed, then we would greatly appreciate any additional funds returned to the unappropriated balance. Mr. Crawford stated that he is very satisfied with the amount they will be giving the Sheriff's Office.

### Executive Session - Special Audit

At 10:25 a.m. Mr. Lee made a motion, seconded by Mr. Fischer to go into executive session to discuss an unfinished special audit at the Sheriff's Office with Lt. Jim Crawford. All vote aye. At 10:38 a.m. the meeting was returned to regular session. No action taken.
