## Litter and Recycling 2012 Update

Mr. Jeff Wherley and Mrs. Tiffany Swigert attended the meeting. Mr. Wherley attended to give his 2012 Annual Report. Mrs. Swigert stated that last week there was a vehicle accident at the fair grounds and there was damage to the Litter Building out there. A formal report has been completed and we will be covered completely. Mr. Wherley presented the Commissioners with a summary of the educational activities that he did for the grant in 2012. He talked about the number of hits to his webpage as well. He then reviewed the 2012 recycling numbers for 2012. He feels our recycling program is going very well. The Commissioners thanked him for attending.

### Discussion - Mike LaVigne - Phones/Equipment

Mr. Mike LaVigne and Mrs. Robin Schonauer attended the meeting to discuss phone and equipment upgrades. Mr. LaVigne stated that we can now fall under the new State Term Contracts on the phones. This will double our connection speeds and decrease our payment by approximately \$2,000 per month. The Commissioners will need to sign a new 5 year agreement. He presented quotes for several servers that need to be updated an also he has 3 SANS that need to be replaced as the manufacturer will no longer support them. The cost to replace all of these is approximately \$38,000. In addition, he will need to replace a couple switches as they are not big enough to continue. The cost is \$12,900 for these. Mr. LaVinge then stated that the county has a spool of fiber. He would like to run the fiber back from the Sheriff's Office to the Annex Building. This will give the county more redundancy. This will cost approximately\$10,000. The Commissioners stated that they would like to purchase the critical infrastructure first and then if there is funding available go to the next item on the list. The Commissioners asked Mike to work with Mrs. Schonauer to make this happen. The Commissioners thanked him for attending.
