county residents. He stated that this program was started over 40 years ago through the Federal Government. The way it works is that the resident will pay based on their income. They would be a huge assistance to Coshocton County Memorial Hospital. They continue to grow in the counties they are established in. He stated that they are requesting a letter of support from the County Commissioners for this grant application to help bring this health center to Coshocton County. Mr. Shryock asked how Board Members are selected. Mr. Atkinson stated that 51% of the board members must be users of the facility. He would probably ask the Commissioners for input on this. The Commissioners stated that they will put the letter of support on the agenda for Wednesday and thanked him for attending.


