2013 CHIP Public Hearing

Mr. John Cleek, CDC of Ohio and Mrs. Robin Schonauer, Budget Director attended the public Hearing for the 2013 CHIP grant. At 10:00 a.m. Mr. Lee opened the public hearing. Mr. Cleek reviewed the proposed activities for the Community Housing Improvement Program in Coshocton County. The primary activities are Homeownership Program, Home Repair, Private-Owner Rehabilitation and New Housing Construction (HFH). The primary goal of CHIP is to improve the housing stock and living environment in Ohio's communities through a multi-faceted housing/neighborhood revitalization effort. He stated that the application process will be probably the most competitive as it has ever been. The grant applications are due this Friday and grant awards may not exceed \$400,000. This year the grant is targeting the Village of Warsaw. By having a target area this will help our grant application. We must use \$100,000 of the \$400,000 in the target area. There are income eligibility requirements for participants. The County median family income is \$50,900 and upper income limits for low-moderate income occupants (80% of County median income). Mr. Shryock then asked about the consolidation of some City CDBG funds to the counties. Mr. Cleek explained that we are just now getting information on this and some smaller cities monies are being included in the county monies. We are having training on this next week and will know more then. That being all, Mr. Lee then closed the public hearing at 10:11 a.m.

Discussion – Jason Given Prosecuting Attorney – Addendum to Minutes

Mr. Jason Given, Prosecuting Attorney and Mrs. Robin Schonauer, Budget Director attended the meeting to discuss a request from Ohio Department of Development and Housing and Urban Development (HUD) for a possible addendum to some previous minutes of the Commissioners. Mr. Fischer stated that as a process of reviewing the NSP Demolition grant that was received by the county in 2009, one of the homes that was submitted by the Village of Warsaw to be demolished was a home owned by Mr. Fischer's mother. At that time, when this came up, a phone call was made to the then Prosecuting Attorney, Robert J. Batchelor and he informed Mr. Fischer to abstain from voting and discussion on this issue. The State of Ohio then reviewed this and found there was not any issue. This was then submitted to HUD and they wanted a clarification of why he abstained in the Commissioners minutes. Mr. Given then stated that he feels the letter that he submitted to Ohio Department of Development with the explanation of events should be sufficient as well as a brief explanation of why this is being done at this time.

Mr. Shryock made a motion, seconded by Mr. Lee to approve an addendum for the following minutes: 9/23/09, 1/4/10, 11/9/09 and 11/16/09 as follows:

Dear Mr. Hiler:

Coshocton County is the sub-recipient of an NSP Grant that is administered by Ohio Regional Development Corporation for the City of Coshocton. Coshocton County used its funding to demolish homes in various areas of Coshocton County, one being the Village of Warsaw. The Village of Warsaw was designated as one of Coshocton County's "target areas", however the Village Administrator, Ed Robinette, struggled to find homes within the village in need of demolition. With that being said, one of the homes Mr. Robinette identified and requested demolition of was owned by a family member of Commissioner Gary Fischer.

It has been brought to my attention that your office is now questioning the legitimacy of the expenditure for the demolition of the property in question. Therefore, in addition to researching the issue, I have also conducted interviews with Judge Robert J. Batchelor. Judge Batchelor was the Coshocton County Prosecuting Attorney at the time the expenditure in question was approved by the Coshocton County Commissioners.

Judge Batchelor informed me that he received a call on or about September 23, 2009 from Commissioner Shryock. He further indicated that Commissioner Shryock requested his verbal opinion as it related to Commissioner Fisher's involvement in the proceedings pertaining to the Fisher property in Warsaw, Ohio. Judge Batchelor informed me that he informed Commissioner Shryock that, in accordance with the guidelines set forth under Ohio Ethics Laws, Commissioner Fisher should abstain from any portion of the process involving his family member's property. Judge Batchelor also indicated that at the time he believed that Commissioner Fisher's abstention resolved any conflict of interest issues. This opinion was given via telephone conference only. Commissioner Fischer did as he was advised and abstained from all discussion and voting on this issue.
