Litter Control Supervisors Report

Mr. John Fielden attended the meeting to provide the Commissioners with his final Activity Report for the Coshocton County Litter Control for the 2nd Quarter 2013. The Commissioners thanked him for his report.

Discussion – Jeff Wherley – Recycling Disposal Issue

Mr. Jeff Wherley attended the meeting to update the Commissioners on where we are with our recycling disposal issue. Mr. Wherley stated that Rumpke is interested at the prospect of working with Coshocton County. Jeff would like to have a central location to haul our recycling materials and then have Rumpke pick it up from there. He stated that Lity is willing to host this and asking that they would like to have the steel and aluminum off the trailers for hosting the site. He stated that Rumpke will charge a fee to collect the recycling they take. He stated that Rumpke is interested in taking over the recycling for our county, but he feels this really won't work for us. The Commissioners stated that at this time, they are looking at a transfer station as Jeff explained above with Lity and not Rumpke taking over our program. We would like to expand the program we have in place and do a central transfer station with them doing the removal from the central station. This will allow us to add more recycling sites to our program. They asked Mr. Wherley to contact Rumpke with this offer. They also asked him to contact J & J Refuse to see if they would be interested in this option as well. Mr. Wherley stated that he will contact both Rumpke and J & J and get back with the Commissioners on Monday, June 10, 2013.

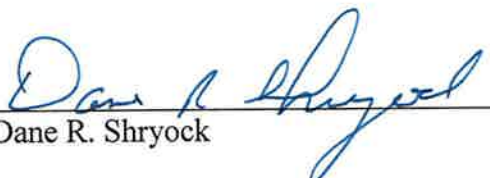
