Mr. Lee asked Mrs. Beck to look into this issue to determine how we are able to dispose of it and get back with them. That being all, the Commissioners thanked him for attending.

Mental Health Programs Levy/Resolution 2013-32

Mr. Rod Hollingsworth and Ms. Beth Cormack attended the meeting to request the Commissioners put a renewal levy on the ballot for the Mental Health and Recovery Programs in November 2013. Mr. Hollingsworth stated that they are asking for a renewal levy of 8/10 mills. They fund three agencies out of Coshocton County. This is a ten year levy. Mr. Fischer asked if it made a difference on the length of the levy since they are going from a 5 year levy to a 10 year. Mr. Hollingsworth stated that as long as there is not a change to the millage, then the length does not make a difference. Mr. Shryock asked if all the monies collected in Coshocton County stay in Coshocton County. Mr. Hollingsworth stated that all tax dollars collected in Coshocton County stay here in Coshocton. Mr. Lee asked if other counties have similar millage to Coshocton. He stated they are all different. Noble County is a 7/10, Morgan County is 8/10 and Muskingum is 1 mill. Mr. Shryock stated that this levy is very important as there are not the mental hospitals available as in the past. Mr. Hollingsworth stated that when he started they had approximately 144 patients in mental health hospitals. Today, they have approximately 14. So, this levy is very important to our communities. Mr. Shryock made a motion, seconded by Mr. Fischer to request the Coshocton County Auditor Certification for a 8/10 Mill Mental Health and Recovery Program Renewal Levy.
