# Storm Damage – Discussion

Mr. Mike LaVigne, Mrs. Robin Schonauer, Mrs. Tiffany Swigert, Mr. Fred Wachtel and Mr. Ike Reger attended the meeting to discuss the damage to county property after the storms last week. Mr. LaVigne stated that we did have damage from the storm. He said there were two 48 port switches that were damaged. One at the Prosecutors Office and one at the Hopewell SSA Building. We have warranties on these switches. We have to return the switch in order to get a new one and he doesn't have any spare switches to use until he gets the switch back. He is not certain if the warranty will be any good since it was damaged by the storm. He then stated that he lost a UPS battery backup in the server room. It will not power on at all and it cost approximately \$976.00. He also stated that his biggest problem of all is that he doesn't have a big enough generator to cover all his equipment. He would like to request again that we move the generator from the courthouse to the annex and use it as a backup and get a bigger generator at the courthouse. Mr. Lee asked what the cost of the generator would be and Mr. LaVigne stated that he only has the quotes from last year and will need to get new quotes. Mr. Lee then asked Mr. Wachtel what his costs were due to storm damage. Mr. Wachtel stated that he had some radio damage but it will cost him around \$300 to repair. Mr. Lee then asked Mr. Reger what Maintenances losses were. He stated that Juvenile/Probate lost a control panel due to water related issues. He is not certain if it was storm damage or just water coming through the wall. They are moving the panel to alleviate this problem. Mrs. Swigert stated that she feels we should turn this in with our claim and it will be covered. Mr. Lee asked about the tree damage at the courthouse. Mr. Reger stated that we will need to take one tree down and have a stump removed and some dead limbs taken from the trees. Mr. Wachtel stated that they have some top soil that the Maintenance Department could utilize. The Commissioners thanked him for this. The Commissioners asked Mrs. Swigert to submit the claim to CORSA and we will go forward from here. As for the back-up generator, they would like to have him get a new quote for the courthouse and the annex. Once they have that, they will then make a decision. They thanked everyone for attending.
