J.A.R. Investors, LLC Relief from Coshocton County Road Standards

Mrs. Tiffany Swigert attended the meeting to explain the following request. She explained that J.A.R. Investors, LLC had originally submitted a variance to Regional Planning for this private road. However, in being discussed in the Regional Planning Executive Committee meeting it was suggested that this should go to the County Commissioners to request relief on the County Road Standards. She stated that they did ask that when the plat for the subdivision is done it have in the title that this subdivision has a private road so that any person purchasing property in this subdivision will know that it is a private road. Mr. Shryock stated that the County Engineer is very in favor of going this route with this subdivision private road. There was a motion made by the Executive Committee to request the Commissioners give relief from the County Road Standards for this subdivision. Mr. Fischer made a motion, seconded by Mr. Shryock upon the recommendation of the Coshocton County Regional Planning Commission Executive Committee to grant J.A.R. Investors, LLC. relief from the current Coshocton County Commissioners County Road Specifications for a private road at 57314 County Road 9 in Oxford Township for a three lot subdivision. This private road will include a maintenance agreement.
