### Senior Center Levy

Miss Diana Caton, Mrs. Susan Riggle, Miss Karen Porter, Mr. Douglas Caton, Mrs. Penny Egler, Mrs. Agnus Bechtol, Mrs. Katherine Diane Hutchison, Mrs. Dorothy Shaw, Mr. Malcolm Shaw, Mrs. Maxine Carnahan, Mr. Bob Fetters, Mr. Preston Palmer, Mr. Russ Gephart, Mrs. Barbara Cognion, Ms. Jaime Williams, Ms. Linda Fletcher, Ms. Mary Beckholt, Ms. Donna Denning and Mr. Mike Stephens attended the meeting to discuss the Senior Citizens Levy request. Mr. Lee stated that we requested to meet with the Senior Advisory Committee as well as Kno-Ho-Co because we had received a letter requesting a renewal with a .25 mill increase to 1 mill. He explained that there will be 7 levies on the ballot for this fall. Mr. Stephens stated that like everywhere else, we are getting funding cuts and the best way to keep the services in place that we have now would be to ask for a renewal with a .25 mill increase to 1 mill. Ms. Williams gave some examples of services they are providing that will be affected unless they have this levy renewal with an increase of .25 mills. She stated that they have reduced 3 staff positions and have made other reductions as well such as evening meals. Miss. Caton stated that the Senior Center is the only place in Coshocton that the seniors can meet together and congregate with transportation, meals and fellowship. They cannot be praised enough. She stated that they have made every cut they can and still sustain the services they provide. She stated that this is very important and she feels we need to have this. Mr. Fischer stated that we need the facts to make a determination about putting the levy on the ballot. Mr. Shryock stated that he hopes everyone in this room understands what will happen if the levy does not pass. There are a lot of levies on this ballot. Miss. Caton stated that she feels this is vital to our seniors. Mr. Lee stated that we will request Auditor Certification for their request and that should be on the agenda for Wednesday. Mr. Fetters stated that he is 72 years old and the Senior Center means a lot to all the seniors with the activities that they offer. Mr. Lee stated that the Commissioners feel that they should not make the determination for this levy and so they will put the request on the ballot in the fall for the citizens of Coshocton County to determine themselves. The Commissioners thanked everyone for attending.

### Fresno/Pearl Lift Stations - Discussion

Mr. Fred Wachtel attended the meeting to discuss some issues at the Fresno/Pearl Lift Stations. General discussion then followed.
