Lt. Jim Crawford - Collective Bargaining Agreement

Lt. Jim Crawford attended the meeting to review the Deputy's Collective Bargaining Agreement and ask the Commissioners to sign-off on it. He stated that he feels it is a fair contract for everyone. He stated that this will cover between 25 and 30 employees. The employees will receive a \$.65 raise over the three year period. Mr. Shryock asked if there were any other significant changes and Lt. Crawford stated that there was not. Mr. Shryock made a motion, seconded by Mr. Fischer to sign the Fraternal Order of Police Collective Bargaining Agreement with the Coshocton County Sheriff which will be retroactive back to January 1, 2013 through December 31, 2015.

Mr. Fred Wachtel - AFSCME Collective Bargaining Unit

Mr. Fred Wachtel, County Engineer attended the meeting to discuss the Engineer's Collective Bargaining Agreement. He explained that the contract went to fact finding and the Commissioners and the Engineer accepted the fact finders report. They have then had more discussions with the bargaining unit and they have agreed that going back to the previous calculations for overtime would be agreeable to everyone and getting a 9 percent raise over the life of the agreement. They have now passed the new agreement. Mr. Fischer made a motion, seconded by Mr. Shryock to authorize Mr. Frederick T. Wachtel, County Engineer to sign a Collective Bargaining Agreement with Ohio Council 8 and Local 343. This agreement will go through August 31, 2015.

Mr. Jeff Wherley – 2014 CFLP Grants

Mr. Jeff Wherley attended the meeting to discuss the 2014 CFLP grant requests. He stated that he does not anticipate more expense for the 2014 grants than last years. He stated he would like to stop having the tire collection day as residents can take tires to local places for the same cost. He feels there is too much time and expense when it is really not advantageous for residents. He would like to get the Commissioners input on this. Mr. Lee stated that does not have an issue with him stopping this collection as long as there are local outlets for the tires. Mr. Shryock asked if local tire shops would take the tires if they were not purchasing new tires. Mr. Wherley stated that he directs people to do that all the time and has not heard that they would not take the tires, but he will check on that. Mr. Shryock stated that since we get up to 1500 tires shouldn't we still offer that service. Mr. Wherley stated that he could keep it in the program for 2014 and state that it may be the last year to have the tire collection. Mr. Shryock stated that we need to find out for certain if local tire shops will accept tires without the purchase of new tires before he is willing to stop this collection. Mr. Wherley stated that he will get back the Commissioners on this. The Commissioners thanked him for attending.

Treasurers Monthly Investment Portfolio

Mrs. Janette Donaker, County Treasurer attended the meeting to present her Monthly Investment Portfolio. Mr. Shryock made a motion, seconded by Mr. Fischer to receive and review the Monthly Investment Portfolio for the month of June 2013 from Mrs. Janette Donaker, County Treasurer.

Mrs. Melinda Fehrman – JFS Update
