# Relocation of the Warning Siren at the City Fire Department

Mr. Rob McMasters, EMA Director and Fire Chief Mike Layton, City of Coshocton attended the meeting to discuss relocating the Warning Siren owned by the County and located at the City Fire Station. Mr. Rob McMasters stated that the City is re replacing the Warning Siren at the Fire Station and he would like to relocate the County Siren to Coshocton City Schools. The cost to do this would be approximately \$7,000. Chief Layton stated that he will pay for the replacement siren at his station. He feels the relocated siren should be moved to Coshocton City School unless the Commissioners have another place they would like to move it. Chief Layton stated that compared to the price of purchasing a new one, it is relatively inexpensive to move. Mr. Fischer stated that on the quote it talked about narrow banding the siren and it possibly not working then. Mr. McMasters

stated that the other sirens have not been narrow banded and he doesn't understand why ours would have to be narrow banded. Chief Layton stated that on a receiver he does not think it is that important to be narrow banded. He does not feel this will change the reception at all. He also stated that he feels the quote is a little high. Mr. Shryock asked if we could get a quote from anyone else. Chief Layton stated that this company is the State Bid Contractor. He is not in this business but he does feel the quote is a little high. Mr. Lee asked if we should get additional quotes for the project. Mr. Shryock asked if this is something a local electrician could do. The Commissioners stated that they would like Mr. McMasters to look into the pricing and get back with them. The Commissioners thanked them for attending.

#### Horizon

Mr. Ken Engstrom, Mr. Steve Steele and Ms. Chris Glassburn, Horizon attended the meeting to update the Commissioners on Horizon's activity in Coshocton County. Mr. Engstorm stated that he is now working with Horizon and he is here to bring the Commissioners up to date on the project. Mr. Steve Steele stated that they have extended their project deadline through the end of this year. When they originally applied for the project they had underestimated what they thought would be necessary for the project. So, they were not able to do as much as they first intended. He stated that they didn't get to all the counties that they intended to and Coshocton is one of those counties. They plan to expand the network into the counties they did not reach at an expense to Horizon over the next 3 years. Mr. Lee asked what 3 counties they did not get to. Mr. Steele stated Perry, Coshocton and Holmes. He stated that they are still working and intend to provide broadband to the 3 counties they did not get to. Mr. Shryock asked if the reason they did not get to us was the lack of population in those 3 counties. Mr. Steele stated that they tried to get permits in place and that kind of drove the areas they went to first as well as the customers they could get to sign-up. The Commissioners thanked them for their update.
