Residential Recycling Changes

Mr. Jeff Wherley attended the meeting to update the Commissioners on the residential recycling changes. Mr. Wherley stated that this is not so much changes, but planning for changes. He said that they plan for 15 years but after 10 years is up, they start the process again. There were a couple things that have come up from the PAC meeting. As it stands now we have 9 sites in the county and all are serviced by the county. He stated that we are looking at acquiring some roll-offs from Licking County. If we go toward the roll-offs, we can then do single stream recycling. He stated that he would like to see our program go to single stream; however, he doesn't really know how this will affect our relationship with Rumpke in Mt. Vernon. He stated that Ms. Carol Phillips would like to see Coshocton County move toward a system like they have in Licking County. He stated that there is a large capital outlay to go in this direction. He stated this would reduce the amount of trips our employee would have to make. Mr. Lee stated that he is not certain we have the money to do this. Mr. Wherley stated that he does not want to contract this out. Mr. Lee stated that he does not feel it would be beneficial to any company to want to contract with us. Mr. Wherley stated that he also feels that you would need to have a CDL license to drive one of the compact trucks as well. He stated that he is really not in favor of moving toward this direction. He feels we should go forward with the small roll-offs and purchasing an additional trailer to haul the roll-offs. He feels this would be the most efficient use of the districts monies for this county. Mr. Lee asked how much the roll-offs cost. Mr. Wherley is not certain about the cost. Mr. Fischer asked if there is a potential of Mt. Vernon dropping us if we go to the roll-off. Mr. Wherley stated that he does not feel that they will do this. Mr. Lee stated that he does not feel we could afford to go to the packer system. Mr. Fischer is in agreement of that. Mr. Wherley stated that this would be a slow transformation. As the Alleycat trailers would wear out, he would then replace them with the rolloffs. The Commissioners feel that if we are going to change in the future, we should move toward the roll-offs as the Alleycat trailers go bad. Mr. Wherley stated that he will move forward with what the Commissioners have stated.
