## Judge Timothy France – America in Bloom Update

Judge Timothy France attended the meeting to give an update on America in Bloom. He stated that this is not so much of a competition but a way to get input from other communities. It is more about getting people involved to improve the community. He stated that he feels we need to get more information out so that everyone knows what we are doing. One of the areas that we need to improve upon is the recycling within the City. He is here to inform the Commissioners that he is trying to work with other entities so that we can all move toward one goal. He stated that he would like to have additional recycling drop boxes at the Courthouse. He stated that he has spoken with Judge Batchelor and he feels he may find some funds to be able to purchase these boxes. He then stated that in the long term they would like to look at putting the fountain back in the Court Square. At this time, these are just thoughts, but he has had some interest in doing this. He stated that he hopes the Commissioners could help him out with some of these plans. The Commissioners thanked him for attending.

## Marc Tower Sub-Lease – Watch Communications

Mr. Tom Knippen, Watch Communications and Mr. Jon Mosier attended the meeting to discuss the subleasing of the MARCS Towers in Coshocton County. Watch Communications has purchased Broadband Networks which was formerly Omnicity. Mr. Knippen gave a history on how Watch Communication began as well as his own background. He stated that their strength is in the service that they provide. He explained their service process. He then discussed some of the facilities that they service. He stated that the process of bringing the county on with them will take some time. He stated that they would like to continue the agreements that are in place at this time. Mr. Fischer asked if the contact number in place for residents now will still work. Mr. Knippen stated that they will use the same number. He also stated that if there is a service problem, they will receive attention within 24 hrs. Mr. Fischer asked where the service representatives are located. Mr. Knippen stated in New Philadelphia. Mr. Fischer then asked what other upgrades will be coming for Coshocton County. Mr. Knippen stated that if they can make money in an area, they will put up a tower. However, if the number of residents is not there, then they will not proceed. He stated that once they get everything up to par, they will then market in areas they feel they can get to people. Mr. Mosier stated that his biggest concern has been in the past residents have called in with service issues and have not been treated very well. He hopes that this will not be the case with Watch Communications. Mr. Fischer stated that he would agree with Mr. Mosier and communication has seemed to be our biggest issue in the past. Mr. Fischer stated that Watch Communications should get us an amendment to the lease in place and we will have our Prosecutor look at it. The Commissioners thanked him for attending.

## Office Space – Transportation

With the recent news of the CVB and the Chamber of Commerce moving from the office downstairs in the Progress Center, the Commissioners have determined that due to the lack of handicap accessibility for the Coordinated Transportation Agency, they would offer them the space downstairs. They asked Director, Tracy Haines to attend the meeting to discuss this issue. Mrs. Haines is looking forward to having handicap accessibility.


