Public Hearing – 1st Public Hearing 2014 CDBG

At 11:00 a.m. Mr. Fischer opened the public hearing and turned it over to Mr. Cleek. Mrs. Robin Schonauer, Mrs. Marge Donley, Mayor of Conesville, Mrs. Raylene Thompson, Conesville Clerk, Mr. John Cleek, CDC of Ohio attended the hearing. Mr. Cleek presented everyone with handouts about what is required by Housing and Urban Development for the CDBG Program. He explained that each year the County receives an allocation from the State of Ohio. At this time we don't know what we will get in the way of the allocation. At this time they feel we will have similar funding to last year. He reviewed each program and explained how they impact a county. He explained the process for the Allocation program. He also discussed some of the eligible activities. He then explained that the City of Coshocton previously received their own CDBG Funding, but are now included in the County. The County is now required to fund at least one project within the City of Coshocton. When the State made these changes, they moved more toward a competitive program. He then explained the Critical Infrastructure Program, Neighborhood Revitalization and Downtown Revitalization as these are all competitive grants. He then talked about Economic Development and Public Infrastructure Programs. These are also competitive grants. He explained that all these grants are based on impact of low to moderate income families. He presented applications to Mrs. Donley and stated that the applications will need to be in his office by May 1st. Mr. Shryock stated that he is glad to see the Village of Conesville take an interest and thanked them for attending. Mr. Shryock thanked everyone for attending and closed the hearing.
