attended the meeting. Mr. Fischer opened the meeting and turned the meeting over to Mrs. Skowrunski, she then turned the meeting over to Ms. Sycks. Ms. Sycks then reviewed and explained the annual process of the Enterprise Zone. She then reviewed the request from Annin and turned the meeting over to Mr. Manning, Annin's representative. He explained that the project was a 50,000 square foot expansion of the facility. The County and City agreed to a 38% reduction in real taxes over 10 years and a 50% reduction of property taxes for over 10 year as well. This began initially in 2004 but Annin did not begin to receive tax incentives until 2005 so there is one year remaining on this abatement. The new jobs created in 2013 were 166 this year. Then number of full-time employees was 162 which are 6 more than 2012. They can say that only 2 jobs were created. These numbers are misleading as the Enterprise Zone plan only allows accountable for full-time employees. Annin hires a considerable amount of temporary workers and this does contribute to the county economy. He then reviewed month by month the number of temporary employees that were hired throughout the year. He stated that there are some other things to note, that being the personal property tax that was phased out in 2009 it was replaced by a CAT tax that Annin does pay. He stated that they hope that tax incentive council will recommend continuance for one more year. Mr. Merrill thanked the Commissioners for allowing them to be here in town. They continue to look for a longer life here in Coshocton. He stated that they continue to perform here in Coshocton and today they have 132 temporary workers at this time. They have started shipping and by the time July will get here they will be done for the season. They expect to keep the temporary workers on through July. Mr. Mercer asked if there was ever any consideration to alleviate the CAT tax for Annin. Ms. Sycks stated that the CAT tax is a State tax and we have no ability to relieve that tax. Mr. Stenner made a motion to continue the abatement for another year, seconded by Mr. Mercer. All vote aye. Ms. Sycks then stated that we have another Enterprise Zone participant and that is McWayne Pipe, aka Clows. Mr. Keith Lintz stated that this enterprise Zone is in its infancy. They have to date exceeded the amount of money they had said they would spend and they have hired additional employees. Mr. Tom Crawford stated that this is a new business and it continues to grow. Their bookings are up about 50%. They have recently expanded to Oklahoma. The pole side of the business has actually helped keep them busier early on in the year. Mrs. Skowrunski stated that she would like to thank them for fixing the building that they are moving into and she has directed some companies to them for space. Mr. Manning asked if they are shipping the poles to Oklahoma and would they be selling to co-ops. Mr. Crawford stated that yes they are shipping to Oklahoma and they have a contract with a co-op in Florida. They are working on getting Ok'd by the IOU's such as AEP. Mr. Fischer asked if the poles weigh less than wood poles. Mr. Crawford stated that they do weigh less than wood poles. He stated that they need to grow at 40% per year. Earlier this year they were growing at 50%. But, they really need to get the IOU's to continue this. Ms. Sycks stated that the abatement will take effect in 2014 and so we do not have to vote on this issue until next year. That being all, Mr. Shryock moved to adjourn the meeting, seconded by Ms. Sycks, all vote aye. The meeting stood adjourned.

Discussion - Ms. Carol Phillips CFLP - 10 Year Plan/Funding

Ms. Carol Phillips attended the meeting at the request of the County Commissioners. Also in attendance was Mrs. Robin Schonauer, Budget Director. Mr. Lee stated that they had intended to meet with the affected departments prior to meeting with Ms. Phillips. General discussion then followed. The Commissioners thanked Carol for attending.

# Mr. Bernie Minet - Hospice Agreement

Mr. Bernie Minet attended the meeting to discuss the Hospice Agreement with the Commissioners. He stated that this is a very similar agreement to Coshocton Health Services. Anytime CCEMS transports a patient from home to a care facility in Coshocton County, Hospice will be responsible for paying for these transports. Therefore, CCEMS will only accept the standard Medicare Allowable Rate. He stated that this can be put on the agenda for Wednesday to allow for the Commissioners to review it more in depth. The Commissioners thanked him for attending.
