Warsaw EMS Update

Mr. Bernie Minet and Mr. Todd Shroyer attended the meeting to discuss a new EMS Station at Warsaw. Mr. Minet stated that he has spoken to Mr. Ed Robinette, Village Administrator at Warsaw about the possibility of the lot and space being provided as long as the EMS will provide a small office area for the Village to utilize. He stated that the Village will tear down the old fire station building and the EMS will build the new building. They will stay in the old building until the new one is finished. Mr. Shroyer stated that he feels this would be a win/win situation for everyone. Mr. Minet stated that they have had the property surveyed and there would be adequate space there for them. Mr. Shroyer presented the Commissioners with some preliminary plans for this project. Mr. Minet stated that this seems to be a very viable option, but we won't know until we move forward with the architect. Mr. Shryock asked if the property would be deeded over to the county. Mr. Shroyer stated that he feels it would have to be done that way. Mr. Shryock also stated that we would need to have an agreement about the Village's use of the property. Mr. Minet stated that he agrees with this and wants to make certain the Commissioners are willing to proceed before going any further. The Commissioners are in agreement that they should proceed with moving forward on this issue. They feel that they should work with the Prosecuting Attorney to make certain all legal issues are answered. The Commissioners thanked them for attending.
