#### Monthly Pay-In Report

Received the Monthly Pay-In Report for the month of March 2014 from Ms. Janet Mosier, Clerk of Courts.

#### Discussion – Judge Tim France – Courthouse Funding

Judge Tim France attended the meeting to request funding for the Courthouse landscaping. Judge France stated that approximately 5 years ago Mr. Bill Fruend put together a 501-C3 for America in Bloom. Mr. Fruend has since left the area and now has turned this over to Judge France. He stated that he has recently gone to a seminar on America in Bloom and he stated that he has learned how other entities fund this. He stated that most are funded via government. He stated that they have been to the foundations and have received funding in the past. He is concerned with how they will continue to exist as funding is very hard to come by. He stated that he has presented the Mayor of Coshocton with the same request as he has given to the Commissioners. Their ultimate goal is to initially get funding from the government and then utilize those funds as a way to continue the funding from private entities. He appreciates all that the Commissioners have done with the court square to date. He would like both the City and the County to contribute to continue Coshocton is Blooming. He would like to purchase containers for the downtown area from second to seventh Streets. He is requesting foundation funding for the purchase of the containers. His intent is to lease these containers to private entities so that they would be able to continue this year after year. Therefore, he is hoping that the Commissioners would be willing to become a part of this plan by contributing funding for this project. He also stated that he has spoken with Judge Batchelor and he is willing to pay for the Courthouse lawn to be treated this spring. Mr. Lee asked if it costs the community anything to have America in Bloom come to our area. He stated that there are some costs to have them come here, but they pay most of the cost on their own. He stated that they will be here in Coshocton on July 7<sup>th</sup> and 8<sup>th</sup>. Mr. Lee stated that when he first was elected, we had to cut out many costs. He is not opposed to purchasing the containers for the court square; however, he is not certain that he is willing to fund this annually. Mr. France stated that he felt they would need approximately 36 on or around the court square. Mr. Shryock stated that they will not be able to make a decision today as they would like to talk with Mr. Fischer who is out of the state at this time. He stated that he does understand his request, and possibly the need for government to be involved. However, he is not certain that is something we would be able to do every year. In the last few years, we have put several thousands of dollars in the maintenance of the Courthouse with tree removal, tree trimming, painting and windows on the Courthouse. Mr. France asked if he could have a list of the upkeep and the costs so that he could give that to the judges of America In Bloom. Mr. Shryock stated that it would not be an issue to get that information for him. He then asked if the Commissioners purchase these containers, would he be required to just utilize them on the court square of would he be able to utilize them elsewhere and will he be able to lease those containers back to the county so that he will be able to maintain them annually. He stated that by knowing this, it will help him plan for the future. Mr. Shryock stated that they will get back with him as soon as possible. The Commissioners thanked him for attending.
