Discussion - Cruiser Leases

Lt. Jim Crawford and Sheriff Tim Rogers attended the meeting to discuss additional cruiser leases for county vehicles. Lt. Crawford stated that we discussed last year leasing cruisers instead of purchasing out right. He stated that when we originally talked about it we discussed a 3 year program and they are here to get the Commissioners thoughts on if we want to continue that. What we have at this time, is a 3 year lease with a one dollar buyout at the end. Sheriff Rogers stated that buying outright and leasing equals out in the end. Lt. Crawford stated that the budget for this year is fine, but next year, we will possibly need additional funding for them. Sheriff Rogers stated that we are asking for 2 SUV's and 1 charger. He stated that these are mid-sized SUV's not the large ones and they are pursuit rated. Rural law enforcement is going to these vehicles. He stated that they have no issue with the Charges, and the SUV's will help deputies get out where they need to be as thy have the all- wheel drive. Mr. Shryock asked what kind of mileage does these SUV's get. Lt. Crawford stated that they get in the low 20 miles per gallons. Mr. Shryock then asked what kind of dollar difference is there. Lt. Crawford stated that the SUV's are an additional \$4,000. Mr. Shryock stated that originally we understood that in the 4th year, we would basically be buying them outright, but the first 3 years would help us on the funding. Lt. Crawford stated that we try to keep the vehicles for at least 150,000 miles and then change them out. This will decrease the amount we are paying for vehicle repair. Mr. Shryock asked if they have funding in their budget to buy them out-right this year. Lt. Crawford stated that they do not have enough to buy them out-right this year. Mr. Shryock then asked him what additional funds will be needed to be able to do this. Lt. Crawford stated that they would need approximately \$60,000 to \$70,000 to buy them out-right. Mr. Lee asked how much interest we pay on these leases. Lt. Crawford is not certain what that amount would be. He will get back with him on that. The Commissioners are thinking about purchasing the vehicles out-right but they would like to discuss this issue with the Budget Director to make sure we have the additional funds that will be necessary. Mr. Shryock stated that we will discuss this and get back with them very soon.

CORSA 2015 Renewal

Mr. Don Parkhill, Ms. Ginny Shrimplin and Mrs. Tiffany Swigert attended the meeting to discuss the 2015 CORSA Renewal. Mr. Parkhill and Ms. Shrimplin presented the Commissioners with the 2015 Renewal and then reviewed the renewal with the Commissioners. Ms. Shrimplin stated that she was presenting good news for the county. We do have a savings this year. The majority of the program costs go into a loss fund and that pays the majority of the claims. If claims go over a certain amount, they then go to a special claims fund. The County has a total of \$6,000,000 in coverage. She then went over all the credits that were given to the county. The total savings to the county are over \$6,000 this year. Plus, the county is getting additional coverage at no additional cost. They have added coverage for cyber-liability. They are offering a new loss control program and it is a preventative maintenance program that provides a computerized maintenance system that can be utilized by counties to help them keep track of maintenance on equipment. There is a cost to the system, but CORSA is paying 75% of that cost. There are many benefits to using this system. She is recommending that the county look into this program. The Commissioners thanked them for their presentation.
