#### **Public Comment**

Public Hearing - 2015 Mobility Manager Grant Application

At 10 a.m. the public hearing for the 2015 Mobility Manager Grant Application was held with Mrs. Tracy Haines, CCCTA Director in attendance. At 10:10 a.m. the public hearing was closed.

## Discussion - Mr. Jeff Wherley

Mr. Jeff Wherley attended the meeting at the request of the Commissioners. Mr. Fischer stated that they have requested Mr. Wherley to attend the meeting to ask why he has not submitted required budget reports to the Solid Waste District. Mr. Wherley stated that he had emailed Mr. Lonsinger and Lt. Crawford to schedule an appointment to discuss this and has never heard back from them. Mr. Lee stated that we can take care of this issue now as it is the Commissioners decision. Mr. Wherley stated that he had frozen his allocations. Mr. Lee stated that he had, but that it was the last year, 2015 that was the concern as he would need to allocate the additional funds. The Commissioners have decided to cut the dead deer program immediately out of the budget to try and make these dollars stretch. Mr. Shryock stated that we still need to consider cutting all the programs in order to make the monies work. The other Commissioners are in agreement with doing this. The Commissioners made the appropriate changes to the requested budgets and the Commissioners asked Mr. Wherley to submit these changes to the Solid Waste District. Mr. Wherley stated that he will submit these new numbers to the District as soon as he gets back to his office.
