Boy Scout Camp – FFA Environmental Testing

At 8:45 a.m. The Commissioners left the office to attend the FFA Environmental Testing at the Boy Scout Camp. At 9:55 a.m. the Commissioners returned to the office.

Private Road Standards

Mrs. Tiffany Swigert and Mr. Frederick T. Wachtel, County Engineer attended the meeting to discuss the Prosecuting Attorney's Opinion on the Road Construction Standards. Mrs. Swigert stated that they have had a public hearing on the Private Road Standards and she would like to go ahead and have the Commissioners adopt a resolution that would determine exactly what the Commissioners would like Regional Planning to be able to approve. Mr. Wachtel stated that he does not feel the county has any obligation towards private standards, as long as this does not come back to the county. Mrs. Swigert stated that Regional Planning and the Commissioners need to determine what position they would like to have toward these Private Road Standards. Mr. Shryock asked if there are other Commissioners and Engineer's that agree with him. Mr. Wachtel stated that there are. He stated that he would like to have closure on this issue. Mr. Shryock stated that if he understands this correctly, this will remove the building of the road going through Regional Planning. Mr. Wachtel stated that there is a two-step process; the first coming through the Commissioners and the second going through Regional Planning. Mrs. Swigert stated that this will still go through Regional Planning to determine access management, soil and water and sewer and then she will bring it to the Commissioners to determine if they want to move forward, then all Regional Planning will look at is the lots and not the road. The Commissioners are in favor of going this route. Mrs. Swigert stated that we will still require a maintenance agreement, but that will be up to them. The Commissioners feel that these are private roads and the county has no jurisdiction on them. Mrs. Swigert stated that the standards do require the private road to be a 60' easement. However, the road only has to be drivable up to 16'. Mr. Fischer stated that these private roads will be clearly labeled as such. The Commissioners asked Mrs. Swigert and Mrs. Beck to get with the Prosecuting Attorney to make certain we follow the proper procedures to make these standards work the way they would like them to.
