ATM Contract - Rain 1 Solutions

Mr. Janet Mosier, Mrs. Kathy Stone and Mrs. Tiffany Swigert attended the meeting to discuss the AMT contract with Rain 1 Solution for the Title Office. Mrs. Stone explained that over the years they have been asked by residents to install an ATM machine at the title office. She has looked into companies and has determined that Rain 1 Solutions would be the company that would work best for them. She stated there will be a fee of \$2.00 to each person that uses the ATM. Those funds will go to Rain 1 Solutions. The Title Office will not take any fees. Ms. Mosier checked with other counties that use Rain 1 Solutions and all responses have been very favorable. Mr. Shryock asked if it would require any security alterations to our buildings. Mrs. Stone stated that she is working with the company and Mike LaVigne to take care of any of these issues. Mr. Shryock asked if any company wants to put an ATM machine in our buildings, would we be able to stop that. Mr. Fischer stated that the Commissioners would like to have this issue looked into before we sign the agreement. Mrs. Swigert stated that she had a couple questions she would like answered as well and Ms. Mosier stated that she will get back to her before Monday. That being all, the Commissioners thanked them for attending.

Update - Moving the Siren from the City Fire

Mr. Rob McMasters and Mr. Troy Cole attended the meeting to update the Commissioners on the moving of the siren located at City Fire Department. Mr. McMasters stated that the siren was going to be relocated today and part of that process has already been done this morning. The original location will not work and they have located another location and Dr. Hire is alright with the new location. There will be an additional cost and he is hoping to get help with the added expense. He also stated that there is a large crack in the pole and he feels they will need a new pole. Mr. Lee stated that the pole is fine and the pole will last another 50 years. He stated that the pole does not need to be replaced. Mr. McMasters stated that the company that is moving it does not feel confident in the safety of the pole. Mr. Lee stated that it will cost approximately another \$2,000 to purchase a new one and he does not feel this is necessary. Mr. Shryock asked why it is just now coming to our attention that the location we intended to utilize will not work. Mr. McMasters stated that they just now met with AEP to get this all figured out. They will be on hold until they hear back from AEP on the additional price for the required change. The Commissioners thanked them for the update.
