Resolution 2014-40 – ½% Sales Tax Increase Renewal - Tabled

Request a motion to sign Resolution 2014-40 to increase the rate of sales tax pursuant to ORC 5739.026 and use taxes pursuant to ORC 5741.023 by ½% (One-half of one percent) to take effect January 1, 2015 for a 5 year period.

Resolution 2014-41 1/2 % Sales Tax Increase Renewal - Tabled

Request a motion to sign Resolution 2014-41 to increase the rate of sales tax pursuant to ORC 5739.026 by 1/2 % (One-half of one percent) to take effect on January 1, 2015 for a period of 5 years.


