Mr. Fischer stated that we will put a resolution on Monday to request the County Auditor Certification and then once we have that we will then complete the resolution for the ballot language. Mr. Shryock asked how OSU was soliciting funds for the levy campaign. Mrs. Erwin-Ellis stated that they are possibly planning a fund raiser as well as soliciting donations. Mr. Shryock asked if they are permitted to collect donations at the OSU Extension Office. Mrs. Adams stated that they are not permitted to accept donations at the office. Mrs. Erwin-Ellis stated that Mrs. Carol Hadrosky is the secretary for the OSU Extension Committee and they are accepting donations at Ohio Heritage Bank and anyone who wants to make a donation can. The Commissioners thanked them for attending.
