Enterprise Zone - Kraft Application Review

Mrs. Dorothy Skowrunski, Coshocton Port Authority, Mrs. Christine Sycks, County Auditor, Ms. Jinni Bowman, Chief Deputy Auditor, Ms. Tammy Hess, Coshocton County Career Center, Mr. Rick Raach, Coshocton County Career Center, Mr. Kurt Bain, Kraft, Mr. Greg Ripley, Deloitte, Mr. Mike Morgan, Kraft, Mr. Steve Mercer, Mayor, City of Coshocton, Mrs. LeeJane Williamson, River View Schools, Mr. Dalton Sommers, River View Schools and Mr. Jerry Stenner, City Services Director attended the meeting. Mr. Gary Fischer opened the meeting and then introduced Mrs. Dorothy Skowrunski. Mrs. Skowrunski stated we are here to talk about an Enterprise Zone for Kraft in Coshocton. It is important that the State of Ohio, Coshocton County, City of Coshocton and the Coshocton Port Authority put together a comprehensive incentive package. These incentives are a major factor in the company's decision to move forward in Ohio because of the competitive nature of the Kraft search. This project will retain 372 jobs with a current payroll of over \$14 million. Additionally, the project will create 300 jobs with an estimated payroll of over \$8 million and a fixed asset investment of \$43 million (\$23 million in building costs and \$20 million in machinery and equipment). Kraft's Coshocton facility manufactures Oscar Mayer Bacon and it produces the vast majority of bacon for the Oscar Mayer business unit on its five production lines. Considered a focus plant, the Coshocton facility produces more than 10 different varieties of bacon sold in retail stores. The Ohio Tax commission Authority approved the recommended JobsOhio -Job Creation Tax Credit of 60 percent for 10 years last month. This tax credit is for Kraft's project in the City of Coshocton to retain 372 jobs and the creation of 300 jobs. At the local level there are 2 incentives, and a Port Authority Sales Tax Savings Financing Structure. Each incentive is subject to applications being submitted to the Coshocton Port Authority and formal approvals by the appropriate board or committee. This morning we are meeting to review Kraft's Ohio enterprise Zone application. The Port Authority is recommending a 75%, 10 year enterprise zone exemption to the Coshocton County Enterprise Zone Committee. Based on an estimated annual real estate tax of \$86,079.20 (Kraft current taxes), this would amount to a total property tax savings at 75% over a 10 year period of \$645,594. Mrs. Skowrunski then turned the meeting over to Ms. Sycks. Ms. Sycks opened the floor for questions. Mr. Mercer asked if the estimated figures put together were for the current taxes of \$86,000 for the building. He asked if they would like to keep that at what it is now. Ms. Sycks stated that she will speak to this. She stated that when Kraft first came here, they got a permit for approximately 12 million dollars, but when looking at fair market value, in actuality it only appraises at approximately 2 million when finished. She said they with the land and building upgrades they are estimating approximately 7 million and she feels this is accurate. She then turned the meeting over to Mr. Fischer. Mr. Fischer stated at this point, the Commissioners must vote to proceed with the application if they so choose.

Mr. Lee made a motion, seconded by Mr. Shryock to proceed with the Kraft Enterprise Zone Application as presented above by Mrs. Dorothy Skowrunski.
