Discussion - William Green Memorial

Mr. Sam Bennett attended the meeting to discuss moving the William Green Memorial Marker from the south side of the court square to the north side near the new Coal Miners Memorial. Mr. Fischer asked if this would be what Mr. Bennett would like to do. Mr. Bennett stated that he is somewhat torn about moving the marker. He would like the Commissioners to make the decision because he feels that if we leave it in place it would be great and if they move it, it would be fine as well. Mr. Shryock asked if Mr. Green was involved in more than just the coal mines. Mr. Bennett stated that he was also part of the AFLCIO. Mr. Shryock stated that he feels that we should leave the marker as it was placed. Mr. Bennett stated that he did have someone give him \$500 to put a brick in Mr. Green's name on the Coal Miners Memorial. He would like to put an electrical outlet on the base of the spot light of the Coal Miners Memorial. The Commissioners stated that they will work with the Maintenance Department on this. County Home Tower Update

Mr. Jon Mosier attended the meeting to update the Commissioners on the progress of work on the American Tower at the County Home. He stated that we are finally progressing and he hopes to have everything complete very soon. He also stated that the Commissioners allowed the Amateur Radio group to put a new tower on the Roscoe site and they are very appreciative. He then stated that they would like to remove the old antennae for \$1,200 and this will help them equip the trailer that the County purchased for them. Mr. Fischer asked about the liability concerns. Mr. Mosier stated that with the easement we have in place, he is comfortable with allowing them to do this. Mr. Lee asked if this will create an issue with Staley's who had agreed to do this. Mr. Mosier stated that he does not feel it will be an issue with Staley's and Staley's will charge \$1,900 to remove the antennae. The Commissioners stated that they have no issue with the Amateur Radio doing this work and we will pay them \$1,200 to do so. The Commissioners thanked him for attending.

Open Bids – Common Pleas Courtroom Renovations

At 10:00 a.m. bids for the Common Pleas Courtroom Renovations were opened with Mr. Pat Kelly, Kelly Architectural and Mr. Scott Lepi, Lepi Enterprises, Inc. in attendance. There was one bidder, Lepi Enterprises, Inc., Zanesville, Ohio with the following bid: \$198,560.00. The Engineer's estimate was \$173,701. This bid is more than 10% of the Engineer's Estimate. Mr. Shryock made a motion, seconded by Mr. Lee to take this bid under advisement.

Discussion - Health Department Grant Reimbursement

Mr. Bob Brems, County Health Commissioner and Ms. Wendy Wilson, Health Department attended the meeting to bring the Commissioners up to date on the new grant reimbursement process at the county Health Department. Mr. Brems stated that they received a memorandum from the Ohio Department of Health on the process of grant reimbursement. They have been awarded 2 new grants, but these grants are reimbursable and they would need to be funded up front and reimbursed back to them. Mr. Lee asked if the grants are 100% reimbursed. Mr. Brems stated that they are reimbursed 100%. He stated that they are seeking grants that they feel are important to the community but these grants are all reimbursable. They are not asking for 100% grant funding up front because these grants are reimbursed quarterly. Ms. Wilson stated that the WIC grant would be one that they would need advanced as well as Help Me Grow, Child and Family Health Services, Healthy Communities and Safe Communities. They would probably need close to \$100,000 in advances that would be reimbursed back to the Commissioners. Mr. Lee asked if these funds would all need to be given at one time and Ms. Wilson stated that they all have different grant years. So, at any one time she does not feel the amount will be more than \$100,000. Mr. Shryock stated that before we can give them an answer, he would like to see how much the possible advance would be at any one time or even for the entire year. Ms. Wilson stated that she will make some reports and get them to the Commissioners. Mr. Fischer asked on the quarterly disbursement are the monies transferred automatically or, do you have to apply for those funds. Ms. Wilson stated that you must complete the quarterly reports and then they forward the monies from those reports. The Commissioners stated that they will wait for Ms. Wilson's report and get back with them as soon as possible.
