Sheriff's Range - Shelter

Lt. Jim Crawford attended the meeting to discuss a shelter for the Sheriff's Range. Mr. Shryock welcomed Lt. Crawford and asked him to proceed. Lt. Crawford stated the Sheriff's Office in the planning stages of erecting a shelter at the range. They have a club house but have torn down the other 2 buildings out there due to the closeness of the range. He stated that it would be a 10 x 80 shelter with a concrete base. He has put a request in to the County Prosecutor about building permits and so forth. He is asking permission from the Commissioners to proceed. The quotes to date are \$5,500 not counting the concrete. The concrete should be right around \$3,000. He stated that they will be soliciting donations for this project. At this time they are not planning on any electrical needs. At this time they have 2 security lights that will be right behind the shelter but will have to reassess once the shelter is built. Mr. Lee asked if they are considering using the Building Trades at the Career Center. Lt. Crawford stated that they have had Mr. Sarchet from the Career Center out and they will be building the shelter. The tentative plan is that they will start soon after the County Fair. Mr. Shryock stated that he is in favor of proceeding as long as they get the proper permits. Lt. Crawford stated he has spoken to Mr. Sarchet about the permitting process and that is why he contacted the County Prosecutor. Mr. Lee stated that he is alright with proceeding with this project as long as they are soliciting donations. Mr. Shryock then stated that we had heard that there are some potential retirements coming up soon and was just checking to make certain there is financial planning for that. Lt. Crawford stated that at this time he has not been told of any retirements for this year. He did state that there will be a retirement in May of 2015. He stated that he will look at the figures and let the Commissioners know as soon as possible if there will be a need for additional funds. The Commissioners thanked him for attending.
