Discussion - County IT Contracts

Mr. Mike LaVigne and Mrs. Robin Schonauer attended the meeting to discuss the possibility of updating the County IT Contracts. Mr. LaVigne stated that it has been over 3 years since we looked at this and in taking into consideration, salary increases, additional employees and other increases he feels that maybe the Commissioners would want to look at increasing the contracts. Mrs. Schonauer stated that at this time we are charging \$1.90 per computer per day and they are recommending that the charge goes to \$2.27 per computer per day. Mr. Shryock asked what the difference in cost would be. Mrs. Schonauer stated that Municipal Court would increase around \$1,200 per year, West Lafayette would increase almost \$1,000 per year and Hopewell would increase approximately \$6,100 per year. Mr. Fischer stated that we are not making money on these contracts. These costs are just for operation only. Mr. LaVigne stated that we really should have addressed these costs annually. Mr. Lee suggested that we send a letter to these entities explaining that this should have been addressed annually but the increase will begin on January 1, 2015. The other two Commissioners are in agreement with this. Mrs. Schonauer stated that we do provide internet to other entities as well. These entities pay different amounts and she would like to make certain we are charging all entities the same amount. The Commissioners are in agreement with making this change effective January 1, 2015. The Commissioners thanked them for attending.
