Mrs. Robin Schonauer attended the meeting to discuss the 2015 Budgets. General discussion then followed.

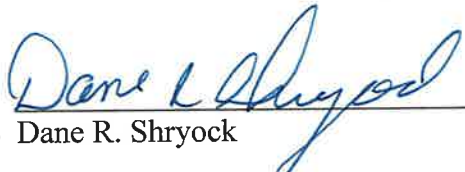
## Change Order #2 – Moving Ohio Forward Grant Program
