Discussion – CSEA Funding

Mrs. Melinda Fehrman and Mr. Danny Brenneman attended the meeting to discuss the requested Child Support Funding that she discussed with the Commissioners a couple weeks ago. Mr. Shryock stated that the Commissioners are trying to confirm the numbers with Mrs. Fehrman. Mr. Brenneman stated that for every dollar the Commissioners would give can be leveraged by the federal government at two dollars. Mr. Shryock stated that was the problem they were having as they could not get Mrs. Fehrman's numbers to work for them as she stated it was 1.66 times and not 2 times. Mr. Brenneman stated that Child Support is the largest leverage they can get. Mrs. Fehrman stated that they used to use their incentive dollars to match at the same rate. However, she stated that the federal government took the ability to do that away. She then stated that Monroe County gives their Child Support \$100,000 each year and they then utilize those monies to garner \$200,000 from the federal government and then pay that back monthly to the Commissioners. Mr. Shryock asked if the Commissioners give Child Support these funds how they would pay these funds back. Mr. Brenneman stated that they would probably utilize the additional funding to pay for the Children Services Detective and reimburse the additional funds back to the Commissioners that way. 1st Public Hearing - 2015 CDBG

At 1:00 p.m. Mr. Shryock opened the 1st Public Hearing for 2015 CDBG Funding. Mr. John Cleek, Lucy McMahon, CDC of Ohio, Mrs. Robin Schonauer, Mr. Jerry Stenner, City of Coshocton, Mr. Don Wells, Tuscarawas Township attended the public hearing to hear about the Ohio Consolidate Plan Annual Action Plan Allocation Priorities. Mr. Cleek stated that this is the first required public hearing for the 2015 CDBG Program. He then reviewed each program as follows: Homeless and Supportive Housing with the following being under that heading: Homeless Crisis Response Program, Housing Opportunities for Persons with Aids. Then we have Affordable Housing with Community Housing Impact Preservation Program, Housing Development Assistance Program (HADP) and CHDO Competitive Operating Grant Program. The Next program is the Community and Economic Development Program. Under this program there are two grant opportunities as follows: Community Development Program and Economic Development & Public Infrastructure Program. There is another category called Other Programs with Target of Opportunity Grant Program, New Horizons Fair Housing Program (1) and Training and Technical Assistance funds. Mr. Cleek then reviewed each program and reviewed what the program goals are. He reviewed the competitive grant requirements as well as the non-competitive grant requirements. Mr. Cleek presented those in attendance with handouts to determine what projects might work best for their community. He stated that they are requesting that the applications for the projects be returned to their office by April 15th. He had project applications for those communities that were in attendance.
