## County Engineers Annual Report


Mr. Frederick T. Wachtel attended the meeting to present the Commissioners with his 2014 County Engineer's Annual Report. He stated that the Engineer's Office is operating on a similar amount of money as was collected in 2007 and it is now 2015. Each year the gas tax collection seems to be decreasing and therefore it makes it difficult to provide the services needed to the citizens with a lesser amount of monies each year. He also stated that the gas tax collection is more than half of his total budget. He then reviewed additional areas of the report and the Commissioners thanked him for attending.

## Coshocton County Head Start County Owned Private Drive


Mr. Wachtel stated that when he was in the Commissioner's Office last week, in passing the Commissioners had asked him to look at the private drive that is county owned going from CR 16 to the Head Start School and determine what if any road improvements are needed there. Mr. Wachtel stated that it is approximately 2018 feet long and they could overlay it, but they will have problems pretty quickly again. One option would be to do full-depth reclamation and then put a double chip/seal on top of that. They could also put an inch cap of asphalt on that as well. He stated that it may cost around \$40,000 to do a chip/seal without asphalt. Add another \$15,000 for the asphalt. Mr. Shryock asked about utilizing HPM. Mr. Wachtel stated that anything like that will work nicely as long as it is applied correctly. The Commissioners thanked him for looking into this for them.
