Discussion - Sales Tax

Ms. Christine Sycks, County Auditor attended the meeting to discuss the recent decline in Sales Tax. Mr. Shryock stated that after the last 2 months of declining Sales Tax, the Commissioners are becoming somewhat concerned. He understands that the State cannot tell us where our decline is, but he felt this warranted discussion. Ms. Sycks stated that she has noticed a decline in the purchase of motor vehicles. She stated that she has spoken with the State of Ohio to determine if a refund that was made in February was going to continue to affect us. She has asked the Department of Taxation for more information, but they have yet to get back with her. She stated that we are down approximately 13% from last year, but still above 2013 sales tax. She stated that if it continues to decline, she will have to decrease her estimated revenue for this year. Once she hears back from the Department of Taxation, she will know more. She stated that once that happens, she will contact the Commissioners and let them know. The Commissioners thanked her for attending.

Regional Airport Loan Discussion

Mr. Bethel Toler, Regional Airport Authority and Mrs. Robin Schonauer attended the meeting to discuss a possible loan from the Commissioners to pay an invoice to the Shelly Company in the amount of \$19,863.63. He stated they have closed out their grant, and have had inspections as well, but they still have not received funds from the FAA to pay this invoice. He stated that the invoice in dated January 2015 and they would like to get this paid and cleared away before they go out to bid on a new project. They are asking for \$17,877.00 from the airport and then the Commissioners match portion is \$1,986.63. Mr. Toler feels that we will get these funds back within a month or so. Mrs. Schonauer stated that the last time we did this, we wrote a check to the Regional Airport Authority and they paid their portion and we paid the match.

Regional Airport Loan - \$17,877.00

Mr. Shryock made a motion, seconded by Mr. Lee to loan the Coshocton County Regional Airport Authority \$17,877.00 to pay the The Shelly Company the final payment in the Contract for FAA Grant 3-39-028-191. The Coshocton Regional Airport Authority is in agreement that this loan will be repaid no later than May 31, 2015.
