## Discussion - Anne Cornell

Ms. Anne Cornell attended the meeting to share upcoming plans for the Pomerene Park. This sits directly across from the Court Square on Main Street. She presented the Commissioner with plans for the park this summer. She stated that there will be a walk through from Main Street to the alley close to where the Commissioners have their employee parking lot. She stated that they are scheduled to start the masonry part of the project. They should have this portion completed by the end of July. She stated that they did receive a grant and are now receiving gifts from local residents as well as businesses. That will help finish the project. This will be outfitted to be a market space as well as do art shows. Once the park is finished, they will handle the Farmers Market. She stated that they are working together to help make the Market a destination and to help energize downtown with the arts. She said that they determined that having it on Main Street was the best option. She stated that she understands that the Court Square is not the place for the Farmers Market and feels the park space will work nicely for it though. She stated that today she is here to ask to be able to utilize the steps that lead up to the main entrance of the court square for music

performers and have an art project as well. The Farmers Market will be on the sidewalk on the Courthouse side of Main Street. Mr. Fischer stated that we do have a lot of activities on the court square throughout the summer. Ms. Cornell state that they did speak with the Canal Festival Committee and they will not conflict with them. She stated that she will be out of the area by noon and she feels this would not conflict with any other function going on the court square. Mr. Fischer asked why they do not just block off Fourth Street and utilize that. Ms. Cornell stated that they felt Fourth Street was too far from the park. Mr. Fischer asked why not utilize Fourth Street until the park is available. Mr. Lee asked who will be responsible for making sure there are no horses or vehicles on the Court Square. Ms. Cornell stated that she is not the Farmers Market and she cannot speak for them. Mr. Shryock stated that he is very much in favor of her project. It is very important for communities and the Commissioners understand this, but the biggest concerns they are facing is the use of the Court Square and she is one person of many. They are trying to maintain the integrity of the Court Square. The question she has before us is if she can utilize the Court Square steps for The Pomerene Centers use. She then presented the Commissioners with a Request for the Use of the Coshocton County Court Square for Saturday May 2, 2014 from 7:30 am - 10:00 pm as they will be holding an evening arts dinner that evening as well. Mr. Shryock stated that we will put this request on the agenda for Wednesday. The Commissioners thanked her for attending.
