Discussion - August 1, 2015 Community Picnic

Mrs. Irene Miller attended the meeting to discuss the Coshocton County Courthouse Renovation Celebration. The Commissioners wanted to discuss the Silent Auction portion of the celebration. Mrs. Miller explained some of her ideas. There will be 7 windows on display in the gazebo, numbered 1 through 7. The Commissioners feel that we should utilize the simplest way to make everything as easy as possible, we should just have a sheet that everyone can sign their name and the amount that they want to bid. Mrs. Miller then reviewed other details of the picnic celebration. The Commissioners thanked her for attending.

#### Discussion – Private Roads Standards

Tiffany Swigert asked the Commissioners for clarification/interpretation on the Private Road Standards that were adopted in 2014 as a result of discussion from the June Executive Committee meeting. The Private Road Standard for 1-3 lots in a "Private Road Subdivision" describe lots in a subdivision. The discussion stems from a situation where there are two homes (users of a private road) on one lot in the subdivision. Currently, the document for 1-3 lots does not mention the lots only containing single family residences, only the number of lots that can be served from the public road. There is questions regarding the intent of the document verses the actual word(s) written in the document. The Relaxed Private Road Subdivisions for Subdivision of 1-3 lots does not speak to the use of the lots or that that there should only be one single family home on each lot being served by a Relaxed Private Road. Whereas the Relaxed Private Road Subdivision of 4-5 lots does. If the intent of the document for 1-3 lots was to only permit single family residences per lot, the proper process should be started to add that language to that document. Mr. Hughett applied for the Relaxed Private Road Subdivision under the current standard and should be reviewed under that standard that was adopted. Future discussions will be held regarding the additional language and whether it should be added to the current document. On the current issue before the Regional Planning Board at this time, the Commissioners feel that the rules in place at this time should be applied.
