Records Commission

Mr. Jed McCoy, Mrs. Susan Turner, Ms. Camila Graham, Mr. Keith Krebs, Ms. Lindsey McCullough, Mr. Jason Given and Ms. Christine Sycks attended the meeting. Minutes for the last meeting were read. Mr. Given made a motion, seconded by Mrs. Turner to approve the minutes. The motion carried. Mr. Shryock asked for disposal requests. Mrs. Susan Turner presented a request for one time disposal of her records. Ms. Sycks made a motion, seconded by Mr. Given to approve the request of Ms. Tuner and forward it on to the State. The motion carried. Mr. Jed McCoy then presented the Commission with a request for one time disposal as well as an update to their RC -2 from the Department of Job and Family Services. Mr. Given made a motion, seconded by Mr. Lee to accept the request and forward it onto the State. The motion carried. That being all, Mr. Given made a motion, seconded by Mr. Lee to adjourn the meeting. The motion carried.

Discussion – Pastor Bill Dunfee

Pastor Bill Dunfee and Mrs. Karla Cullison attended the meeting to discuss some issues with the Commissioners. Also in attendance at the request of the Commissioners was the Prosecuting Attorney, Jason Given. Pastor Dunfee stated that he came to speak with the Commissioners to get some answers and guidance. He presented the Commissioners with some laws and ordinances. He then asked what if any oversight do the Commissioners have over the Sheriff, Prosecutor and Law Directors Office. Mr. Shryock stated that we have fiduciary responsibility only for those offices. He then asked do we have any ordinances or laws that affect the county. Mr. Lee stated that we have no legislative authority. The State of Ohio sets the laws. He then stated that the oversight is only fiduciary. Pastor Dunfee stated that they have pretty significant laws being broken because of the nudity going on in the Village of Warsaw. He stated that the county does have jurisdiction in this area. Mr. Fischer stated that the Village of Warsaw does contract with the County Sheriff to provide this service. Pastor Dunfee then stated that there are things going on in Warsaw that break the laws in disseminating nudity harmful to minors. He requested the Commissioners to watch a video that shows these issues. Mr. Shryock asked if the Commissioners have no jurisdiction over this, why they would watch this video. Mr. Given stated that he could not see a reason for the Commissioners to watch this video. Mrs. Karla Cullison then utilized her laptop and played the video for the Commissioners. Pastor Dunfee then stated that no matter how they try to protect their children this is what we see. He asked the Commissioners if they felt this is something that is breaking the law. Mr. Shryock stated that he cannot interpret the law and will not comment. Mr. Fischer stated that he also will not comment. Mr. Lee stated that he feels Pastor Dunfee has the ability to stop this, but he really had no comment other than that. Pastor Dunfee stated that he works within the confines of the law. He stated that the individuals that are now picketing their church are not lawful and he is looking for solutions. He thanked the Commissioners for their time.

Mowhawk Dam

Mrs. Dorothy Skowrunski, Coshocton Port Authority, Mr. Ken Woodard, Mr. Kurt Buchanan, Mr. Adam Kays, Ms. Jami Buchanan and Mr. Gus Drum attended the meeting. They presented the Commissioners with the Mohawk Dam – Dam Safety Modification Study process that will begin soon. Mr. Woodard stated that they are kicking off the study of the Mowhawk Dam. Everyone in attendance works for the Army Corp of Engineers. He then reviewed the history and location of the dam and explained the need for the dam. Mr. Kays then stated that the dam does have seepage, but all dams do have seepage. He reviewed the actions taken at the dam over an approximate 85 year period. He then discussed the seepage locations and the work performed. He then stated that they performed an Issue Evaluation Study (IES) and it was recommended that a Complete Dam Safety Modification Study be done. Ms. Buchanan then reviewed the Safety Modification Study and what it will consist of. They will estimate existing and without action condition risks and how to address these risks. She stated that they go through a six step process in this study. She then reviewed their plans to move forward and gave the Commissioners some dates of future events. She also stated that they are here in the community and want the Commissioners know what is going on and what the future plans will be. Mr. Drum then stated that in the planning stages they must go out 50 years and assess the changes that they will be making at this time to benefit for the entire period. Another thing they must look at is if the dam were to have a problem they must determine the at risk persons. That being all, the Commissioners thanked them for attending.
