Ohio Children's Trust Fund

Ms. Leanne Rohr and Mrs. Melinda Fehrman attended the meeting to discuss the Ohio Children's Trust Fund. She explained there are some changes in the Ohio Children's Trust Fund. She stated that currently every county gets an allotment from the Ohio Children's Trust Fund. With the regionalization, we will now become part of a region of 11 counties. She stated that there is a grant request for one of the counties to be the regional administration of the grant. She stated that she does not feel this would be good for Coshocton County. The County Commissioners role in all this will be to appoint 2 representatives from the county to serve on this regionalization board. She then reviewed the appointment requirements and this appointment must be made between September and December 2015. Mrs. Fehrman stated that this will be an interesting experience to see if the collective counties in the region will find the same things important as the board in Coshocton County Children and Family First Council does. She also asked if they would like the council to make recommendations of who should serve on this regional board. The Commissioners stated that they would like the Children and Family First Council to make this recommendation. The Commissioners thanked them for attending and will wait to hear from them after the council meets in December.
