Licking County Offer - Mr. Jeff Wherley

Mr. Jeff Wherley attended the meeting to discuss Licking County's proposal to take over Coshocton County's recycling sites. He feels we will still need to have our employee pick up our institutional sites as well as pick up a couple of sites in Licking County. He gave the proposal to the Commissioners. Mr. Lee questioned whether or not Rumpky or whoever would want to drive to Bakersville, Tiverton or any of our other sites. Mr. Wherley stated that he does not know for certain, but Licking County thought we could work together and acquire a company to do both counties. The Commissioners stated that they will look at the proposal and get back with him. Mr. Shryock asked what Perry County does. Mr. Wherley stated that they contract with PERCO for their services. Mr. Shryock stated that he understood Licking County no longer did any of their recycling collection. Mr. Wherley stated that they do collect their institutional collection and they would like to expand as well. Mr. Fischer stated that he has a concern that if the sites don't get as much recycling as Rumpky or whoever gets the contract would like, then what are our options for those areas going to be. Mr. Wherley stated that it would have to be in the contract with Rumpky or whoever and they would be responsible for the retrieval. Mr. Wherley stated that geographically we are very different from Licking County. Mr. Shryock asked what we will do when and if the price falls and no one wants the recycling. Will we need to start our recycling over all over again? At this point, we don't fear change, but if things are working now, why would we want to change this. Mr. Lee stated that he cannot imagine a company wanting to come in and take our recycling right now. Mr. Fischer stated that he agrees that he is not afraid of change, but what works for Licking County probably will not work for us. Mr. Wherley stated that we have a wonderful employee and he doesn't want to short him, but he is trying to be opened minded to determine what will work best for us. Mr. Shryock stated that possibly we need to look at what is inefficient in our process and change that to make it better. Mr. Wherley agreed with this suggestion. Mr. Wherley stated that if the Commissioners have any additional questions, he will be happy to answer them.
